FIRST DEFIBRILLATOR IN THE PARISH

CATSHILL now has its first, of what we hope will be several, defibrillators. It has been installed on the Pavilion in the Meadows field, and was made possible by funding secured by the New Homes Bonus scheme. In February, the village hall was the venue for training on how to use the equipment. Rob Underwood, founder of Charlotte and Craig's Saving Hearts Foundation, supplied this training, and the event was very well attended. The defibrillator will be maintained by Catshill and North Marlbrook Parish Council.

A further unit will be sited at Catshill Baptist Church on completion of the building works, and following requests



The Neighbourhood Plan initiative is really taking off with a good cross section of individuals involved in the Steering Group, however, they are going to require a good number of volunteers in the various working groups covering issues such as Housing, Infrastructure and Environment; so please get involved - they need you.

The Steering group is chaired by Doc. Chris Fabray and incidentally the Christmas Party he sponsored for the older members of our Parish was a great success. It was heart-warming to see all of the volunteers working at transporting people to the event, cooking the food, Councillors and other volunteers serving the food, and even an old Paratrooper arriving on his mobility scooter and acting as Father Christmas. This can be done on line by visiting the Parish Web site and following the link or by obtaining a hard copy of the questionnaire from the Village Hall or other locations that will be posted on the web site. Additionally, you will find a copy on the middle pages of this magazine that can be completed and cut off for return. This is important to the future of your village.

The Ladies toilet is now complete and open in your village hall (very posh). We will try and bring the Gents to a similar standard. I thanked everyone by name in our last issue, however thank you again to everyone that made this possible.

There are going to be two or possibly three defibrillators located in the village in the very near future. Watch out for the training programmes and get involved; you may be able to save a life.

I understand we are not using our village library enough. If it is not used and funding is removed, it will be a great loss.

The main areas of concern reported within the village are still Traffic related; speeding, parking spaces, inconsiderate parking etc. This is difficult to address but be assured your Council is putting every effort into trying to solve the problem.

Do please attend our Annual Parish meeting on April the 20th at your Village Hall; have a listen, a cup of tea and maybe give your views.

Catshill Library



WE have in Catshill, a fabulous facility in the local community library, located to the left of Catshill Middle School, via its own separate entrance. It is a small and intimate space, that many people prefer to the larger libraries.

There is a good stock of fiction and nonfiction books catering for all ages and interests, from books for babies and young children through to the latest fiction for adults and all for *Free*. In addition you can

borrow audio books and DVDs from £1.40 per week.

As well as lending books, the library offers a number of other services and holds regular events:

- Reservations of stock can easily be made, for a small fee.
- There are 4 PCs for Internet browsing and a printer, ideal if you do not have a computer.
- A photocopier, at present the only one publicly available in the area.
- Every Monday at 10:00 a.m. a song & rhyme session for babies and toddlers
- On the 2nd Monday of each month, an adult readers group at 6:30 p.m.
- On the first Saturday of each month, a storytime session for younger children at 10:30 a.m.

BorrowBox is a new service that makes it easy to browse, borrow and listen to the library's eAudiobooks and eBooks anywhere, everywhere.

Install the app for Apple, Android or Amazon Fire devices or download to a PC then simply login with your membership details to access the library's collection.

Finally, our thanks go to Catshill Social Club for allowing us to serve refreshments there after the service, and to Andrew Bate who was on hand to assist anyone wishing to find out more about the local men who died in both world wars.

Catshill Baptist Church Building



IT'S always exciting to see building improvements taking place, but often in order to create new improved buildings, older building have to be demolished first. This is the case with Catshill Baptist

Church who decided that in order to extend their service to the local

community they needed to modernise their church hall, catering facilities and also increase the floor space available to accommodate the groups and organisations that they support.

Modernising in this case meant demolishing the old hall so that a new larger one can be built. These photographs show where the original hall was, and where the new larger hall will be.

Once all the improvements have been completed, the church feel that the building will be able to the meet its current and most importantly, its future demands.

What is a Neighbourhood Plan?

THE concept of *'Neighbourhood Plans'* was introduced under the Localism Act 2011 and they are fundamentally about giving rights to local communities about the type, location, size, pace and design of developments in their area.

Neighbourhood Plans can;

• Decide where and what type of developments should happen in the neighbourhood area



• Include policies such as on design standards, which could take precedence over existing policies in the Bromsgrove District Council Local Plan for the neighbourhood.

Neighbourhood Plans are primarily about the use and development of land and could include the following;


- Housing developments, including affordable homes, and bringing vacant and derelict housing back into use.
- Provision for business to set up and expand their business.
- Issues around roads, cycling, walking and disabled access.
- Development of schools, places of worship, health, leisure and entertainment facilities, community and youth centres and village halls.
- Protection and creation of open space, nature reserves, allotments, sports pitches, play area, parks and garden, and tree planting.
- Protection of important buildings and historic assets.
- Promotion of renewable energy projects.

Why is a Neighbourhood Plan so important! - because it puts You in control and -

- Sets out what our community wants regarding:
 - Environment, conservation and green space
 - Types of Housing and Design
 - Local Economy, amenities and shops
 - Society Community and Culture
 - Transport, Parking and Pollution

- Controls Undesirable ad-hoc development
- It is our community's vision and strategy for the future up to the year 2030.
- The completed Neighbourhood Plan will be approved by a local referendum and will then carry legal weight in the planning process.

There is a legal requirement for Bromsgrove District Council to take into account the contents of local Neighbourhood Plans when making future decisions on planning for those areas. The District Plan has just been agreed by the Council and more houses will need to be built by 2030 to meet Government targets.



Catshill and North Marlbrook Parish has now been designated as a Neighbourhood Plan Area A Steering Group under the authority of the Parish Council has been set up to oversee the completion of a Neighbourhood plan for this Area. The initial consultation is fully under way and an explanatory leaflet has been produced together with a questionnaire to collect people's views on the important issues for

them within Catshill Parish. Drop in workshops are being held in the Village Hall on Saturday 13th May and Saturday 24th June betwen 11am and 2pm.

It shows Church Road, Catshill, and was almost certainly taken in the early 1970s. It clearly shows the tall white house known as the "Laurels" which at one time was the Nailmasters house, along with the adjoining buildings that were for many years part of the Premier Bin Manufacturing Company.

All of these buildings were demolished to make way for Marsh Way.

Dog Fouling

THE Parish Council have recently received several complaints about dog fouling in this area. I think we can all agree that this is a really unpleasant, unhygienic and antisocial problem. To be forced to clean footwear after inadvertently stepping into dog mess must be at the top of the list of obnoxious tasks (don't even think about trainers with deep tread patterns!) It is also a serious health hazard. Dog faeces contain harmful bacteria, and possibly roundworm eggs which can cause illness or, even, blindness in children.

If you are aware of a badly fouled area, you can contact Bromsgrove Environmental Services, Council's Street Scene (01527 881188) so that they can deal with it.

If you are walking your dog, please take a disposal bag with you and pick up after your dog. Bagged waste can be disposed of in any Council dog litter bin or litter bin (most

litter bins are now marked for use for both litter or dog waste), or take it home for disposal. Dog bag dispensers are located at strategic locations throughout the area, but failure to have a bag with you or lack of a nearby bin is not an excuse. Remember, failing to pick up after your dog is an offence which can be subject to a spot fine!

Speeding and Parking

TWO areas of great concern from residents within Catshill is both speeding and parking. These issues are difficult to address, but the Parish Council do their best to assist with these matters.

Parking

West Mercia Police are also aware that inconsiderate, poor parking is one of the public's biggest concerns. There is an interesting article relating to this at *www.westmercia.police.uk/article/5987/Parking*. Within this article it does state that if you have a problem with illegal and inconsiderate parking in your community you can raise concerns with your local policing team in order to progress with this situation. The Safer Neighbourhood Team for our area is Bromsgrove North and Rural and further details can be found at *www.westmercia.police.uk/article/2186/Bromsgrove-North-and-Rural* The direct email address for the team is *bnr.snt@westmercia.police.uk*. Alternatively, by contacting the Parish Council, we can process your concern in this way too.

Speeding

If you have any concerns regarding speeding within the Parish you can contact the Parish Council who will liaise with the Safer Neighbourhoods Team within West Mercia Police. Further information about this team can be found at the following link: *www.westmercia.police.uk/article/2186/Bromsgrove-North-and-Rural* They will in turn liaise with the Safer Road Partnership, who, once they receive a request, will collect speed data at the site to establish if there is a speeding issue and to determine the nature of the speeding problem if one exists.

Please continue to assist us to monitor this issue within the Parish. A particular area of concern at present is the Stourbridge Road and the Parish Council are liaising with the relevant agencies to obtain speed surveys in this area.

Proposed 20mph speed limit

Due to the lack of Highway safety in the Catshill area, Members are minded to approach Worcestershire County Council with a proposition to impose a 20mph speed limit around the area of the new Co-operative store but to also extend the length of Meadow Road and

encompass the entrances to all three schools in order to assist with the safety of Parents and children accessing the sites. This has letters of support from all schools and the Parish Council will also be consulting the Co-op for their views. There is currently a pilot being carried out in Rubery to ascertain if 20mph speed limit signs have any effect on traffic. If this is deemed to be unsuccessful, any application we make would not be accepted. However, in the hope that the pilot will be successful, the Parish Council wish to continue with the application to WCC. Prior to this, it is important that we consult with residents. If you have any strong views regarding this, please do not hesitate to contact us.
